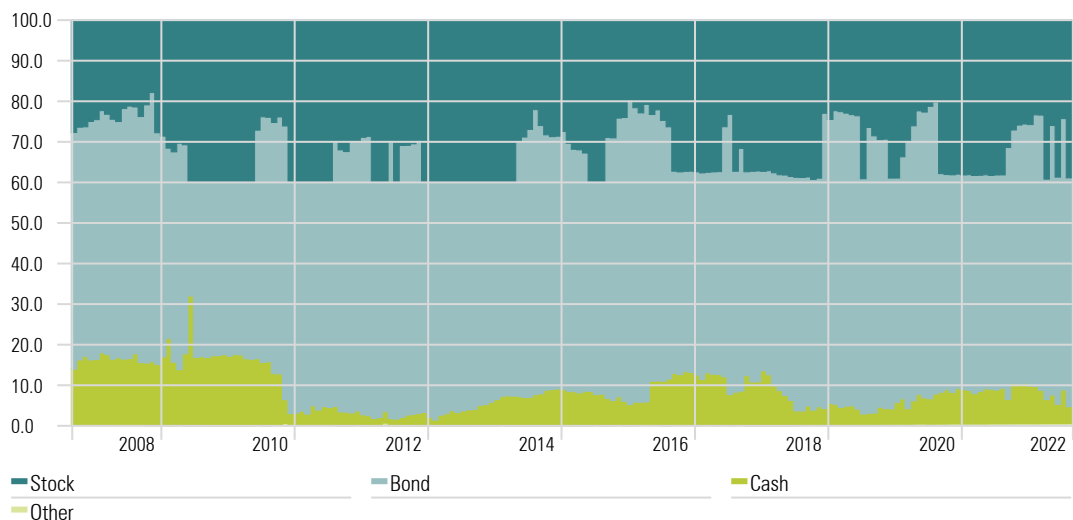
Investment Growth
