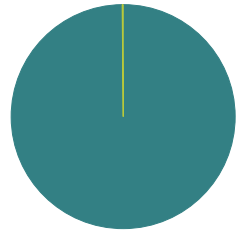

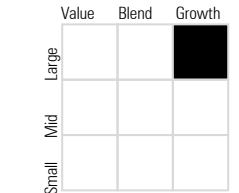

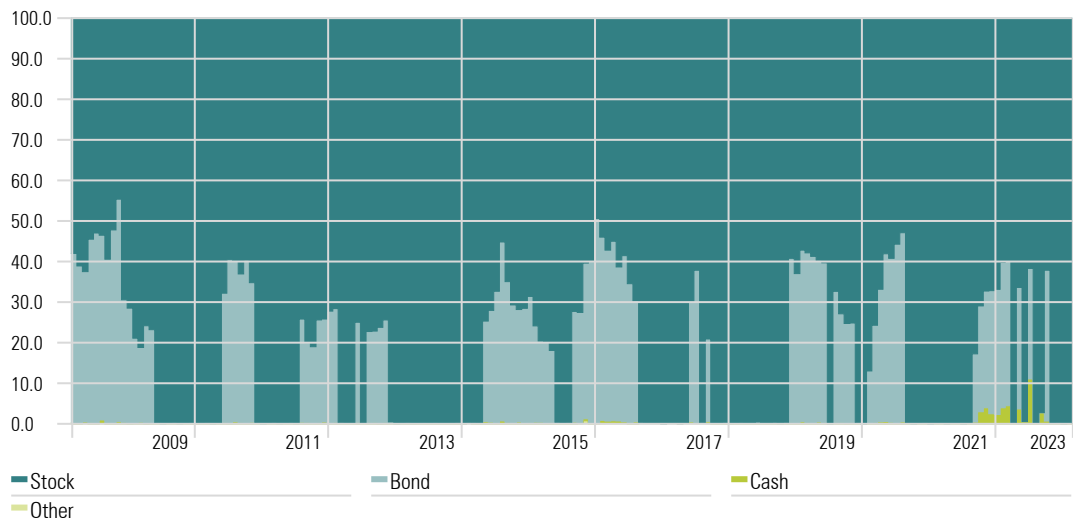
### Investment Growth
